



NOTICE 240 of 2022 LEVEL 6 WATER RESTRICTIONS

Implemented with immediate effect in De Rust and Dysselsdorp and Klein Karoo Water Supply Scheme (KKRWSS)

- Households are encouraged to reduce water use to not more than 50 l/person/day and may not consume more than 6kl/month.
- No washing of cars using municipal drinking water.
- No cleaning of paved / concrete / tarred surfaces and structures with municipal drinking water.
- The use of municipal drinking water for any construction or building purposes (including cleaning roofs with high-pressure/low-volume cleaners) is prohibited.
- Irrigation of gardens with municipal drinking water is prohibited.
- Plant Nurseries and Motor Wash businesses to obtain permission from the Technical Department to use municipal drinking water for their businesses. All applications for permission must be accompanied by a detailed method statement indicating how much water will be used and what measures will be put in place to conserve water referring to industry best practice water conservation norms and the recycling of water. Emergency water tariffs will apply.
- Topping up or filling all (private and public) swimming pools with municipal drinking water is prohibited.
- Fountains and water features remain shut down.
- Irrigation by water other than drinking water is clearly indicated at the front of properties where such irrigation takes place, e.g., "**BOREHOLE WATER**".
- Irrigation of any sports fields as well as the watering of agricultural land, paddocks, parks, lawns, and open spaces with municipal drinking water is completely prohibited.

KENNISGEWING 240 VAN 2022 VLAK 6 WATERBEPERKINGS

**Geïmplementeer met onmiddellike effek in De Rust en Dysselsdorp en Klein Karoo
Watervoorsieningskema (KKRWSS)**

- Huishoudings word aangemoedig om nie meer as 50 l water per persoon per dag te verbruik nie en mag nie meer as 6 kl / maand verbruik nie;
- Geen was van motors met munisipale drinkwater nie;
- Geen skoonmaak van geplaveide / beton / geteerde oppervlaktes en strukture met munisipale drinkwater nie;
- Die gebruik van munisipale water vir enige konstruksie- of konstruksiedoeleindes (insluitend die skoonmaak van dakke met 'n skoonmaakmiddel met hoë druk / lae volume), is verbode;
- Besproeiing van tuine met munisipale drinkwater is verbode;
- Plantkwekerye en motorwasbesighede moet goedkeuring vanaf die tegniese afdeling verkry om munisipale water te gebruik vir hul besighede. Alle aansoeke vir goedkeuring moet vergesel word van 'n gedetailleerde metodeverklaring wat aandui hoeveel water gebruik sal word en watter maatreëls ingestel sal word om water te bespaar verwysend na die norm vir die bewaring van water in die bedryf en die herwinning van water. Noodwatertariewe is van toepassing;
- Die opvul of volmaak van alle (privaat en openbare) swembaddens met munisipale drinkwater is verbode;
- Fonteine en waterfunksies bly gesluit;
- Besproeiing deur gebruik te maak van water buiten drinkwater moet duidelik aangedui word aan die voorkant van eiendomme waar sodanige besproeiing plaasvind, bv. **"BOORGAT WATER/GRYSWATER"**;
- Besproeiing van enige sportvelde asook die natmaak van landbougrond, paaie, parke, grasperke en oop ruimtes met munisipale drinkwater is heeltemal verbode.

Hierdie water beperking sal van toepassing wees op alle water verbruikers in die Groter Oudtshoorn Munisipale gebiede, insluitend De Rust en Dysselsdorp en die Klein Karoo watervoorsiening skema (KKRWVS).
